- Elections
  - Special election for President:
    - Tom will run, other can nominate themselves on the spot
    - Ida will try to find two non-SASgov members to help with the elections
    - Ida will bring ballots
  - After election Ida will say that Akshay nominated Tom as the new GAPSA SAS rep after Hailey got elected onto the executive board.
- Constitutional Amendments:
  - Make sure there is institutional memory
    - Nicole will try to make a google group for us so we have a place to save all passed and failed resolutions and amendments
  - Grievance committee:
    - Academic grievance committee established by Eve Troutt Powell, not SASgov
      - Policy chair + two additional members
        - Tom will make sure the procedure for appointing the two members is clear in the constitution
      - VP Policy should have as one of their first tasks to reinitiate the internal committee for grievances.
        - Must be done before there is any problems within SASgov
  - o Robert's Rules of Order
    - We should all look it up online
  - Amendments of the constitution 5 days in advance instead of 10 days so it can be submitted after an exec meeting or policy meeting instead.
  - o Transition meeting an executive transition meeting, not a GB one.
  - o The President votes as a tie-breaker, though not for the election of him or herself
  - Final election will be announced at the beginning of the spring
  - Recall procedure for elected representatives
    - For the time being bring in a suggestion box/ complaint box so that people can submit anonymous complaints against executive members (or other complaints/ suggestions).
- Asminet asked about the new executive representative. We should still all get \$2000 and Akshay will not claim his part. Then we can give Akshay money out of the contingency fund for the job he has done if we want to do so once he no longer is the President.
